**Robert Stewart, RCS Designs – Wetland Permit By Notification – 55 Barden Hill Road (M 20, L 1).** - Robert Stewart described the proposed project as the repair of an existing stone wall. He noted that the repair was necessitated by damage caused by wake from boats on the lake and will prevent erosion behind the wall. The wall will be done with mostly the rocks currently on site with dry construction (no concrete).
