Susanne White made a motion to approve the minutes. Jennifer Crawford seconded the motion. The motion carried unanimously.

TIF Document

Mike Tardiff said they received comments from Town Counsel directing them to add more language to the TIF document. It was more detail about a potential plan. Since then, there have been public hearings with no questions being asked. He said he thinks it muddies the water to put the numbers in there, but you have to have your plan. This is a potential scenario. You need a developer developer's agreement and interest on the part of the property owner. You must have what a potential scenario could be, all the way down to how you could bond it. It comes down to this potential scenario and continuing to educate the public.

Kim Opperman said it needed to be sold to the public that the developer is going to pay for the improvements or it's not going to go anywhere.

Mike Tardiff said there are developer dollars and there is bonding that may happen; we don't know until there is a development plan. We need a willing developer. Any bonding would have to go to Town Meeting.

There was further discussion about the TIF plan.

Survey Results

Parking spaces were a strong result on the survey. There was discussion about parking and the number of available parking spaces

There was discussion about the enforcement of the Town's parking regulations. Kim Opperman said that the Selectmen have taken the parking away and the Town can't grow. They are giving out 27 overnight permits and that's it. There was discussion about parking.

Mike Tardiff said that parking is something that needs to be worked on. It has brought a lot of passion from the responses.

Riche' Colcombe said we do need to bring a recommendation to the Selectmen about our parking and address the limitations on overnight parking.

Kim Opperman said he wouldn't mind paying a permit fee.

Mike Tardiff said what he is looking for is more direction to help the EDC have more information to help the Board move through these issues. We need to revisit the parking issues.

There was further discussion about parking issues and the empty parcel that is available to be a parking lot.
