At that time the Bids received will be publicly opened and read. It is anticipated that the Notice of Award will occur on or before **March 18th, 2026**, dependent upon voter approval at Town Meeting Day (if necessary).

Work to be performed under this project shall include, but is not limited to, bituminous sidewalk, granite curbing, shoulder reconstruction, pavement markings, signage, drainage improvements, landscaping and other highway related items
