April 28, 2026

Unapproved Minutes Draft Hillsborough Town Offices, School St.

Vice Chair James McDonough called the Hillsborough Conservation Commission (HCC) meeting to order at 7:02 pm. Doug Lischke was appointed to vote in place of Richard Head.

Members present: Vice Chair James McDonough, Jim Riddle, Terry Yeaton, Linda White, Roger Shamel, Jim Narloch, Doug Lischke (Alternate).

Staff: John P. Segedy, Recording Secretary & Alternate; Riche` Colcombe, Trust Fund Trustee.

Public: Steve Gehman.

VISITOR BUSINESS

a. **Riche` Colcombe, Trustee of the Trust Fund** – Spoke to the Commission regarding a trust fund that was labeled ‘Conservation Mon’. She needed to know what it was for and the source of the funds. (Taxpayers or donor) (Original principal \$2500, current balance \$2907). John Segedy said it was a monitoring fund donated when an easement was accepted. Riche noted that there was also a PSNH Monitoring Fund. Commissioners were unsure which property this one was for. (The Smith easement was suggested as a possibility). Chair Head will be queried.

Linda White suggested having the cut checked by the Town Forester. Consensus was to do so. John Segedy will reach out to him. Steve Gehman said he would take a drive by the property.

The Masons will get back to the HCC. Andy Edwards expressed interest in viewing the area and will contact Chair Head to set up a time to do so.
- c. **Confluence Conservation Area** – The HCC reviewed a Draft letter regarding ‘No Dogs during nesting season.’ James McDonough will submit it to the Messenger and the Hub. A sign was discussed. Jim Riddle said he would get one and install it.

Linda White moved: *To authorize spending up to \$50 for a sign.*

Roger Shamel seconded. Motion passed 7-0.

It was suggested to post as a Public Notice on the Town Web page. John Segedy will arrange that. The clean-up session was discussed.

- d. **Signs & Maps** – Jim Riddle updated the HCC on distribution of hiking trail maps.
