## OLD BUSINESS

a. **NRI (Natural Resources Inventory)** – Linda White reported on the responses from the 33 property owners that Moosewood Ecological would like to visit. 10 landowners have granted access permission, one has denied permission, one request was returned and we are awaiting replies from the other owners.

b. **Forestry Update** – John Segedy reported he had reached out to the Town Forester who had recommended using the State Forester. She has been contacted and will try to check out the property of concern for the HCC.

c. **Summer Intern Plans** – Jack Blevens spoke to the HCC about possible tasks he could undertake over the summer. Linda White reported that she had not received a response from Jeff Littleton regarding possibly working with him on some of the property reviews he was doing as part of the NRI. Jim Riddle suggested updating stories about trails and properties he had written last year and submitting them for publication in the Messenger & HUB. Steve Gehman suggested setting up game cameras on some of the HCC's properties. He offered to lend cameras and assist in working with him on this. Roger Shamel suggested adding Mailboxes & notebook-visitor logs similar to the one at

the House Rock property. As an aside it was noted that the parking spot for the House Rock property is still in need of a load of gravel. John Segedy will follow up with Town Administrator Laura Buono to remind her of the previous request. It was requested that Jack notify the HCC of any needs noted in his travels on the trails. It was agreed that Jack would focus on hiking the trails and revising his stories, with additional pictures. Jack will contact Leigh Bosse about getting the stories in the Messenger. The stories and photos can also be posted on the HCC's website.

**d. Signs & Maps** – Jim Riddle noted he was out of trail maps and that he has been asked for some for the upcoming History Alive event. Terry Yeaton suggested that he have some maps of the Riverwalk trail printed for the event.

**Richard Head moved:** *To authorize the expending of up to \$250 for printing 200 town trail maps and up to 50 Riverwalk maps.*
